Program Key Priority Area *

Mental Health Priority Area 7: Stepped care approach

Aim of Activity *

To provide a welcoming and accessible entry point for people experiencing mental distress, mental ill health, and /or addiction, and their families and carers through service navigation to connect consumers to the right mental health service at the right time to meet their identified needs through their preferred platform. GPs, psychiatrists and other health professionals may also use the Head to Health phone service to find service options for their patients.

Description of Activity *

The Head to Health Phone/Digital Intake Service provides a central point for people to speak to someone about mental health issues and receive information and advice about mental health and AOD use. Consumers requiring more than information or assistance navigating available services will be provided with an assessment of their needs, to be undertaken using the Commonwealth's Initial Assessment and Referral (IAR) Decision Support Tool (DST) tool enabling the seamless connection of consumers to appropriate local services to meet their identified needs.

Partnership

As key system partners, Brisbane South PHN and Metro South Addiction and Mental Health Services (MSAMHS) are working collaboratively to deliver this service under our joint regional priority of Integrated Care Pathways.

MSAMHS operate a 24/7 centralised intake, assessment and referral function through MH Call, which is focused on providing access to specialist supports within MSAMHS and hospital settings. Our model collaborates in a joint approach, integrating MH Call and the Head to Health service to ensure seamless initial assessment and referral across the care continuum.

The service is delivered through a tripartite partnership between Brisbane South PHN, MSAMHS and the commissioned service provider. The partnership is enacted through governance structures and formalised through governance agreements. The service delivery partner is co-located with MH Call and utilises Metro South Health's telephony system, with access to their Client Management System. MH Call offers support to people contacting the service after hours.

Service Navigation

By working collaboratively with local mental health service providers to develop strong working relationships, a seamless service pathway will be provided to consumers. A holistic approach to care has been enacted, including linkages to services that address a broad range of social, physical and emotional needs, supported by best practice in evidence-based and evidence informed care. The service complements and does not duplicate existing services, including crisis phone lines and state-based acute care intake services. Consistent triage is promoted to enable transfer and referral to the most appropriate services including Head to Health adult mental health centres and satellites, as available, community-based mental health services, including those provided by the Hospital and Health Service, NGOs or private providers.

Place Based Approach

Flexibility for regional variation to address local population needs and to make optimal use of already available services will be provided. Services under this activity are delivered across four sub-regions: Brisbane, Logan, Beaudesert and Redlands, in line with the Mental Health Priority Area 4: Mental Health Services for severe and complex mental illness. This place-based approach to care provision ensures that priority populations gain access to evidenced based interventions aligned to their mental health needs. A program logic model will be maintained identifying appropriate outcome indicators, with reference to the Brisbane South PHN Performance and Outcomes Framework.

A place-based communications and engagement strategy will underpin our implementation and ongoing development.

Outcomes

In broad terms, the following outcomes for consumers and carers are expected:

- -People requiring support will recognise Head to Health as an accessible entry point to the mental health care system for the services and information they need.
- -People will be able to access, or be connected to, the particular mental health and related services they are assessed as needing.
- -People will receive the most appropriate service for their individual needs; and
- -Demand for services and waitlists are actively monitored at a national level with the aim to connect people to a level of care based on their assessed needs.

Description of Activity *

The long-term objective of the service model is for people in the Brisbane south region to enjoy better mental health and social wellbeing. This will be achieved by:

- Addressing service gaps identified in the provision of low intensity services for people in under-serviced areas, making optimal use of the available service infrastructure and workforce including primary care system by utilising feedback from services users, service providers and evaluations of previous programs at the local level.
- Implementing and monitoring a low intensity service model that is appropriate for people who are at risk of or developing early signs of mental illness.
- Commission programs to holistically address the needs of the individual and link other available services to ensure seamless transitions through the continuum of care between low intensity and mild to moderate services.
- Service offerings will include lower intensity evidence based clinical supports, peer supports, therapeutic groups and exploration of available digital health resources and education to provide a step up and down option to individuals.
- Continue to improve referral pathways between the broader community and primary care system liaising closely with General Practices (GPs) and providing a central point of referral

• Service offerings will include a range of delivery modalities including outreach, face-to-face, telephone and online services based on community advice and local needs.

This will prevent unnecessary service escalation to headspace primary programs and offer an appropriate step down from more clinically based interventions.
- The addition of low intensity service enhancements will improve access to evidenced based interventions for young people with, or at risk of, mild mental illness who do not require the Better Access or Psychological Therapies programs.
- Based on the principles of early intervention, these low intensity services will support self-management and emphasise skill development. Highly focussed and short-term in delivery, these enhancements will provide a key platform within the stepped care

approach to better align with the young person's changing needs.

- Service delivery will include group and individual interventions across a variety of suitable modalities including outreach, face-to-face, telephone, digital health and online services.
- All interventions will be delivered by an appropriately trained workforce with clinical supervision. Where appropriate the workforce will include a peer and/or lived experience workforce.

Low intensity provision enhances service capacity and accessibility for people requiring higher intensity levels of care.

- Integrate service with available psychosocial support services to provide a holistic approach.
- All interventions will be delivered by an appropriately trained and diverse workforce with clinical supervision. This would include a mixture of appropriately trained and qualified mental health professionals and lived experience workforce where appropriate.

A program logic model will be maintained to manage appropriate outcome indicators, with reference to the Brisbane South PHN Performance and Outcomes Framework.

The purpose of this activity is to support General Practitioners (GPs) and clinicians in the primary care setting, using the stepped care model to select the least intensive level of care, for a person presenting for mental health assistance by using the Initial Assessment and Referral (IAR) tool.

Description of Activity *

An IAR Training and Support Officer has been engaged to support General Practitioners (GPs) and clinicians in the Brisbane South PHN region to learn about, use and embed the IAR in clinical practice and workflow. The Training and Support Officer completed the required Train the Trainer course and has developed a localised implementation plan. The plan will be delivered with support from internal and external stakeholders with a focus on embedding the IAR process into existing support pathways. Specifically the plan encompasses:

- Communication and promotion to GPs and other health professionals through a variety of existing Brisbane South PHN channels, publications. Key partners have been identified and are actively starting to raise awareness of the availability of IAR training.
- Delivery of training to GPs and other health professionals through online and face-to-face modes.
- Delivery of training to Metro South Health practitioners will occur following consultation with mental health teams to identify the most appropriate contact people to promote training further.
- The development of remuneration processes and RACGP Continuing Professional Development (CPD) points for GPs who have completed training.
- Project Management documentation and mechanisms to monitor the rollout of training, including progress towards achieving the target number of GPs.

Aim of Activity *

The Supporting Recovery Pilot is designed to improve coordination and access to Family Domestic and Sexual Violence (FDSV) trauma informed recovery services for victim-survivors who have experienced FDSV and ensure supports are delivered appropriately, effectively and consistently. The Pilot Program is designed to reduce touchpoints and ensure victim-survivors have access to integrated and coordinated services to ensure safety and ability to engage in FDSV trauma informed mental health therapies to enable a sustainable recovery.

Specifically this activity aims to improve integration and wrap around supports to victim-survivors.

Description of Activity *

Evidence suggests adults and children who experience family, domestic and sexual violence and childhood sexual abuse, often experience significant mental health conditions as a result, including anxiety, depression, post-traumatic stress disorder (PTSD) and complex PTSD. These can last for many years with recovery requiring an extensive range of supports, including a focus on mental health supports.

The Local Care Teams component of the Supporting Recovery Pilot will be embedded within existing services to improve integration and wrap around supports to victim-survivors. The service will offer culturally sensitive, trauma-informed and personcentred services by assessing need, and then coordinating access to the most appropriate local services, including specific services

for children and young people. The Local Care Team will be involved in intake and referral. Referral pathways into the Local Care Team will include Health to Health Assessment and Referral Phone Service, walk-ins, Recognise, Respond, Refer (RRR) program, 1800 RESPECT phone line, as well as family court and other FDSV programs. Initial assessment will be undertaken to determine the mental health and other support needs of the victim-survivor. Professionals involved in this stage will be FDSV trained, trauma-informed and culturally safe to ensure the process is not traumatising for the victim-survivor. The outcome of this stage will be an integrated recovery plan including up to two-years of mental health support.

The Local Care Team will also provide care coordination and case management, facilitating warm-referrals to mental health services or other services as required e.g. legal, financial, housing. The Local Care Team will remain with the victim-survivor as a single point of contact during this journey.

This activity will be delivered in accordance with the Supporting Recovery Model of Care (March 2023) and supports MH 7.4 – Supporting Recovery – Mental Health Services.

The Strengthening Recovery from Family, Domestic and Sexual Violence pilot recognises that victim-survivors often need life-long support to recover and heal from trauma. The Local Care Team will provide warm referrals to FDSV-specific, trauma-informed mental health services. The new services will be commissioned to provide up to two years of subsidised, ongoing support to

victim-survivors. A range of holistic psychological therapies may be offered, including culturally informed and traditional healing where appropriate.

Aim of Activity *

To provide accessible psychological therapies and other appropriate supports to the range of people impacted by the recent floods in the Brisbane South PHN region. This will specifically involve (1) commissioning local mental health services to meet immediate psychological needs of communities (2) supporting communities in their recovery through well-being and resilience grants (3) supporting young people 12-25 through headspace.

Description of Activity *

Services will support individuals, families, and communities impacted by the disaster and to support recover and build resilience across the flood affected communities.

(1) commissioning local mental health services to meet immediate psychological needs of communities. Mental health supports will be accessible within community across flood affected areas, to support access to psychological therapies in recognition of the long-term implication on mental health and wellbeing for the community.

Mild to moderate mental health services

- -Address service gaps in the provision of psychological therapies for underservices areas specifically those affected by the floods, making optimal use of the available service infrastructure and workforce including primary care system.
- -Service offerings will include higher and lower intensity clinical supports, and therapeutic groups to provide a range of opportunities to engage within the community.
- -Service offerings will include a range of delivery modalities including outreach, face to face, telephone and online based on community advice and local needs.

-Access to mental health supports for priority populations will be a priority for the response ensuring that those with additional barriers have the opportunity to access supports.

(2) supporting communities in their recovery through well-being and resilience grants.

Community wellbeing and resilience grants will be accessible to organisations in the Brisbane south region to increase the delivery of non-clinical supports. An understanding of community needs, including ongoing impacts on recovery and resilience building, has been gained by working closely with those organisations supporting communities at a grass-roots level.

(3) supporting young people 12-25 through headspace

Additional resource will focus on enhancing the existing flexible delivery model to enable mental health supports to be offered in response to the needs of young people in the community as it presents from each local perspective. Enhanced service deliver will include brief interventions, group work and individual intervention across a variety of suitable modalities within headspace centres to specifically target those impacted by the floods.

Aim of Activity *

The Head to Health Adult Mental Health Satellite sites aim to provide a welcoming, low stigma, soft entry point to engagement, assessment and treatment for people who may be experiencing distress or crisis, including people with conditions too complex for many current primary care services but who are not eligible for or who may need more timely care than that available from the state public community mental health.

It is designed to offer immediate, short and medium term episodes of care and service navigation to connect people to ongoing services. It will assist adults seeking help in times of crisis, or as needs emerge, to have access to on-the-spot care, advice and support provided by mental health professionals.

Description of Activity *

Two Head to Health Adult Mental Health Satellite Sites will be established in the Brisbane South region. Satellites will work collaboratively across the Head to Health network including the Head to Health centre and Phone Service.

The Head to Health Adult Mental Health Satellite Sites are designed to offer immediate, short and medium term episodes of care and service navigation to connect people to ongoing services. This will assist adults seeking help in times of crisis, or as needs emerge, to have access to on-the-spot care, advice and support provided by mental health professionals.

Services available at the satellite sites will:

- -respond to people experiencing crisis or in significant distress;
- -provide a central point to connect people to other services in the region, including through offering information and advice about

mental health, service navigation and referral pathways for individuals and their carers and family;

- -provide in-house assessment using the IAR-DST to connect people with the most appropriate services, and;
- -provide evidence-based and evidence-informed immediate and short to medium term episodes of care, including utilisation of digital mental health platforms.

Through a co-design process, the provider will lead the development and design of the service to best:

- -complement available services in the region,
- -manage demand in a way that enables access to immediate support and advice for all who present,
- -provide short to medium term episodes of care for those for whom services are not available,
- -build a skilled multi-disciplinary team,
- -identify and where possible meet unmet local or cultural needs whilst having a standard suite of services,
- -offer after-hours services in a way which is sustainable from a duty of care, workforce and budget perspective; and
- -develop partnerships needed to offer a range of services and referral pathways.

- To support the long-term sustainability of the headspace program by improving access to services, appropriately managing demand and improving the health outcomes of young people aged 12 to 25 with, or at risk of, mental illness access headspace services, and their families.
- To develop a strategy in a collaborative manner to reduce wait time to services for children and young people accessing headspace services in the Brisbane south region.

Description of Activity *

- To develop and implement wait time reduction strategies in collaboration with the Brisbane south headspace centres and headspace National Office (hNO). The need was identified based on the FY18/19 allocation of funding on headspace National's Centre Demand Survey, which was a self-report data from headspace centre managers. Further monitoring and feedback has surfaced significant increases in demand and resulting increases in wait times exacerbated by the impacts of COVID-19.
- To work with key stakeholders including headspace National, local communities and advisory groups to co-design and implement developed strategies.
- To enhance workforce capacity and optimise centre infrastructure to increase service capacity and responsiveness.

A program logic model will be developed to identify appropriate outcome indicators, with reference to the Brisbane South PHN Performance and Outcomes Framework.
