### Activity Priorities and Description

**Program Key Priority Area \***

**Aim of Activity \***

To fund a nurse lead model of care that delivers health, housing, and social support to people who are unsheltered, or who are recently housed but require ongoing assistance across the Brisbane, Logan and Scenic Rim catchments.

**Description of Activity \***

This activity will deliver direct nursing care (e.g. wound care, screening/testing, assessment, mental health support, substance use support, health education etc.) as well as care coordination and case management to people who are sleeping rough, at risk of homelessness or who are homeless.

The program will operate within an integrated healthcare and supportive housing model, which has the overarching aim of settling people into sustainable housing.

Objectives of the activity include:

1. Address gaps in primary care services through delivery of an outreach model of care that is suitable and appropriate for the target population.
2. Facilitate care coordination and ongoing support for consumers accessing services.
3. Deliver services in geographic locations identified as having higher needs.
4. Support consumers to access ongoing care in the management of chronic health conditions

Outcomes of the program will include improved health status and quality of life for people experiencing homelessness (or those vulnerably housed). The delivery of equitable access of service to vulnerable persons, along with reduced health system costs (primary care investment vs. hospital expenditure).

### Activity Priorities and Description

**Program Key Priority Area \***

Population Health

**Aim of Activity \***

This activity aims to:

- Address service gaps in the region to improve primary health care access by people from CALD backgrounds
- Support services for people from CALD backgrounds that are designed to reduce barriers and challenges to accessing and navigating primary care services
- Promote coordination between services at a local level, supporting local service providers in have skills and systems to provide effective care that integrates with the individual's usual primary care provider.

**Description of Activity \***

The initiatives provided under this activity are designed to address local and system challenges people from a CALD background face when accessing primary health care. The activities described align with the principles and actions in the PHN Multicultural Health Framework.

Cultural responsiveness:

- Commission health literacy projects for CALD communities: The project will upskill people of CALD backgrounds with influence in their communities to educate their communities about health and the Australian health system in order to improve their efficacy in successfully accessing and navigating the Australian health system, including reducing barriers such as stigma. This project builds on work commissioned to specialist providers since 2020.
- Capacity building activities for primary care: This activity will develop and provide activities that will build the skills of primary health professionals to provide care for CALD patients in a culturally and clinically appropriate manner through:

- peer-to-peer education from our multicultural health GP clinical lead
- in-house general practice support and guidance
- online cross-cultural, health literacy and interpreter engagement training
- clinical education events
- development/distribution of resources (tip-sheets, guidelines, quality improvement toolkits, referral pathways).

- Development of health literacy campaigns: This activity will develop/promote community focused health literacy campaigns to increase awareness of local health services. It will be done in collaboration with communities, state health and local multicultural health and community services.

#### Localised and tailored activities:

- Care Coordination Service. A Care Coordination Service will be funded to supplement service provision to avoid Emergency Department attendance, including referral to more appropriate care such as social services, medication support or drug and alcohol support services. The service will provide care coordination for people with chronic conditions and bio-psychosocial stressors who are at rising risk of hospitalisation and of avoidable deterioration. The aim is to establish non-clinical supports so that patients can improve their chronic disease self-management. Support is provided for needs such as social isolation or vulnerabilities and difficulties managing health, appointments and medication. The service addresses a gap in our bio-medical model of primary care where GPs/nurses are neither equipped nor reimbursed to manage the social determinants of health which are important to ensuring good health outcomes. All participants are linked into a GP as the primary care provider as part of this service. This service has been commissioned since 2019 and services a large number of CALD and refugee participants.

- Interpreting for AHPs program. An interpreting program will be funded to support alternative providers of primary care services for CALD communities. This activity provides gap funding for interpreting services for private Allied Health Professionals (AHPs). The Government's Free Interpreting Service pilot for AHPs is only available in 2 out of the 4 Local Government Areas in our region and does not include all disciplines (e.g. dentists, mental health nurses or diabetes educators). Our Interpreting for AHPs program, established in 2016, provides free interpreting for those who can't access the Government's service. This ensures general practices can refer to private allied health services that can access interpreting services at no cost across our whole region.

- Pasifika Maternity and Child Health hub team leader and community connector. The team leader and community connector roles work to improve primary health care service integration within the region for Pasifika and Maori communities. These roles are vital for the Pasifika Maternity and Child Health hub to continue to support the integration across key stakeholders from health and other sectors with mothers/families attending the Hub, with the aim to improve health literacy and service navigation. This work will continue and extend on commissioned service provision from a specialist provider since 2020.

#### Meaningful partnerships

-Pasifika and Maori Health & Wellbeing Strategy. This strategy aims to address challenges and barriers faced by the community when accessing primary health care. This activity involves coordinating the implementation of the Pasifika and Māori Health and Wellbeing Strategy across a range of health and community organisations to improve outcomes for Pasifika and Māori people. **Aim of Activity \***

The aims of this activity are to:

- improve the efficiency and effectiveness of after-hours primary health care services through provider support initiatives.
- increase access to culturally safe after hours care for First Nations people and assist in reducing First Nations non-urgent emergency department presentations.
- implement and evaluate service navigation initiatives and improve consumer and provider understanding of available after hours services.

**Description of Activity \***

This activity has been informed by the 2024 Brisbane South PHN after hours deep dive needs assessment and is comprised of three related initiatives.

**Provider support**

The Brisbane South PHN after-hours deep dive needs assessment identified a need for further support and training for the after hours workforce to better cater to the needs of Brisbane south's diverse communities. Local providers will be engaged and supported to improve systems and/or skills to provide effective after hours care and embed quality improvement approaches. Provider support activities may include a focus on service navigation, cultural safety, and/or urgent care. As part of this activity, a new Brisbane south after hours and urgent care advisory committee will be established to provide expert guidance and direction for new initiatives.



#### Expected outcomes

- Increase in knowledge, skills and/or behaviour of providers
- Demonstrated local quality improvement initiatives are embedded
- Improved patient experience

#### First Nations

Brisbane South PHN's after hours needs assessment highlighted priority populations, including First Nations people, experience additional barriers to accessing care, have exacerbated needs, and therefore require a need for tailored after hours healthcare solutions.

Brisbane South PHN, in partnership with Brisbane North PHN, will commission the Institute for Urban Indigenous Health (IUIH) via a direct approach procurement. The activity will support the extension of culturally safe and accessible after hours primary care services for First Nations people to help meet the growing demand and needs of the First Nations community in the region.

The activity focuses on enhancing IUIH's existing strengths-based model of care and extending primary care services into the afterhours period, across 7 clinics (Community Controlled Health Services) and a region-wide virtual and telehealth service (Mob Link). Mob Link provides access to same day care or support to connect to a variety of health and social services, for example GP and Nurse health advice, mental health support and advice, and linking to other health and social services. The activity will also promote care coordination and integration between local services.

#### Expected outcomes:

- Improved availability and access to after hours services for First Nations people
- Increased provision of culturally safe care for First Nations people
- Reduced after hours non-urgent ED presentations for First Nations people within the Brisbane south region.

#### Service navigation

The Brisbane South after hours needs assessment found that consumers reported low knowledge of services and high confusion about service navigation within the region. In this activity Brisbane South PHN will partner with Brisbane North PHN to launch, maintain and evaluate a Service Navigation website (and deliver relevant health literacy campaigns). The website will include information about after hours service availability and scope within the region. Tailored strategies will be developed to increase service navigation health literacy across diverse communities within the Brisbane South PHN region.

#### Expected outcomes:

- Improved health literacy and service awareness in the community
- Consumers have increased understanding of, and empowered to use, the after hours services available in the right place at the right time.
