program logic model will be maintained identifying appropriate outcome indicators, with reference to the Brisbane South PHN Performance and Outcomes Framework.

Service Navigation

Brisbane South PHN has implemented a number of strategies under this activity to improve service integration and system navigation, including embedding 'Connector' functions and/or navigation hub with each commissioned CPSP service provider and directly employing a Services Coordinator, System Navigation to drive program activity across the region in accordance with the PHN guidance.

NDIS Testing Support

Brisbane South PHN has embedded NDIS Testing Leads within each commissioned CPSP service provider to build internal capacity and capability to assist consumers with collecting the evidence to submit an access request and walk with consumers while they take part in the NDIS testing process, in accordance with the guidance. In this way we aim to ensure a sustainable legacy beyond the funding term.

Capacity and strengths-based assessments

Capacity and strengths-based assessments are required by all commissioned service providers as per the guidance. The most appropriate tools have been chosen to meet the needs of the target cohorts in agreeance with Brisbane South PHN and service providers

Regional Loading

The regional loading allocated will support service access to communities in the Southern Moreton Bay Islands, as per the guidance.

PHN Operational funds contribute to the enabling infrastructure alongside program staff (1.8 fte). Program staff required as a minimum to have tertiary qualifications in health (focusing on mental health) and/or community services related discipline.

Continuity of Support (CoS) will support participants previously accessing the D2DL, PHaMs and PIR programs to maintain appropriate levels of support after they test eligibility for the NDIS and deemed ineligible through the extended transition program. Participants will receive ongoing support in accordance with the CPS Guidance material.

Description of Activity *

CoS will ensure participants who have previously accessed support under PIR, D2DL and PHaMs programs, and have been found ineligible for the NDIS, continue to receive appropriate psychosocial support using a recovery and strengths-based framework. The key aims of CoS will include:

- Increasing personal capacity, confidence and self-reliance
- Increasing social participation
- Streamlining access to appropriate services
- Providing flexible and responsive support at times of increased need
- Supporting participants to re-test their eligibility with the NDIA if they are unhappy with their access decision or their circumstances have changed
- Provide psychosocial supports to participants of Commonwealth community mental health programs that are ceasing (PIR, D2DL and PHaMs)
- Both individual and group base services will be offered

- not be restricted in their ability to fully and actively participate in the community because of their residential settings (e.g. prison or a psychiatric facility); and
- not be receiving or entitled to receive similar community supports through state or territory government programs.
